MINUTES OF MEETING

The following Faculty/Staff Members attended a meeting on 24.05.2024 at 2:30 pm for Disciplinary Resource Committee (DRC)/Anti Ragging Cell for the academic year 2024-2025; all members unanimously agreed that for the forthcoming academic session, and "In view of the directions of the Hon'ble Supreme Court in SLP No. 24295 of 2006 dated 16-05-2007 and in Civil Appeal number 887 of 2009, dated 08-05-2009 to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, in all higher education institutions in the country, and thereby, to provide for the healthy development, physically and psychologically, of all students, the committee brings forth these Regulations."

The Committee to ensure:

- To make the community at large and the students in particular aware of the dehumanizing effect of ragging, and the approach of the institution towards those indulging in ragging, big posters (preferably with different colors for the provisions of law, punishments, etc.) shall be prominently displayed on all Notice Boards of all departments, canteen, main gate and other buildings as well as at vulnerable places. Some of such posters shall be of permanent nature in certain vulnerable places.
- To give adequate publicity to the law prohibiting ragging and the negative aspects of ragging and the institution 's resolve to ban ragging and punish those found guilty without fear or favour.
- The committee shall identify, properly illuminate and man all vulnerable locations.
- The committee shall identify tighten security in its premises, especially at the vulnerable places. If necessary, intense policing shall be resorted to at such points at odd hours during the early months of the academic session.
- The committee shall identify utilize the vacation period before the start of the new academic year to launch wide publicity campaign against ragging through posters.
- To Display colourful Anti- Ragging Posters in the College of Art Campus that ragging is totally banned and anyone found guilty of ragging and/or abetting ragging is liable to be punished.
